

AN ORDINANCE

**ALLOWING CONSUMPTION OF ALCOHOLIC LIQUOR WITHIN SPECIALLY DESIGNATED AREAS AT A SPECIFIC LOCATION
ON JULY 31, 2020 FROM 6:00 P.M. to 12:00 MIDNIGHT AND AUGUST 1, 2020 FROM 6:00 P.M. to 12:00 MIDNIGHT.**

WHEREAS, K.S.A. 41-719(c) prohibits consumption of alcoholic liquor on public property;

WHEREAS, K.S.A. 41-719 (e) allows any county to exempt, by ordinance, from the provisions of subsection (c) specified property the title of which is vested in such county;

WHEREAS, K.S.A. 41-719(a)(2) allows alcoholic liquor to be consumed at a special event held on public streets, alleys, roads, sidewalks, or highways when a temporary permit has been issued pursuant to K.S.A. 41-2645; AND K.S.A. 41-2645 (e) allows cities to grant such a temporary permit by ordinance; and

WHEREAS, the Governing Body of the City of Leoti desires to promote special events to be held during the Wichita County Fair approved by the Wichita County Fair Board.

WHEREAS, the Governing Body of Wichita County, Kansas passed Resolution 2020-9 allowing consumption of alcoholic liquor at the Wichita County Fairgrounds on July 31, 2020 and August 1, 2020

THEREFORE, BE IT ORDAINED, by the Governing Body of the City of Leoti, Kansas:


1. The request by Wichita County Fair Board for special events held during the Wichita County Fair in specially designated areas on July 31, 2020 and August 1, 2020 from 6:00 p.m. to 12:00 midnight is hereby approved.
2. Pursuant to K.S.A. 41-2645 (e), a temporary permit for the consumption of alcoholic beverages is granted for the following public streets, alleys, roads, sidewalks, or highways: area on the east side of the Wichita County Rodeo Arena specially designated as drinking areas by the Wichita County Fair Board within the Wichita County Fairgrounds from July 31, 2020 and August 1, 2020 from 6:00 p.m. to 12:00 midnight
3. Provided however, that such street, alley, road, sidewalk or highway is to be closed to motor vehicle traffic by the governing body during such time.
4. The boundaries of the special event shall be clearly marked by signs identifying the area in which alcoholic liquor may be possessed or consumed at such special event.
5. No drinking will be allowed in vehicles. Attendees shall abide by all laws of the city and state.
